

Terms of Booking

The following Terms of Booking cover all general model and event production hires unless otherwise stated.

RATES

Editorial and Commercial Hire Rates

- Models for photography assignments are supplied on either an hourly, half or full day hire rate.
- A 20% agency booking fee is added to all hire rates.
- Reduced fees are available for registered Scottish charities and Students.

Event Hire Rates

- Set fees are available for event hires such as catwalk shows, PR and promotional events.

Travel and Fitting Fees

- Travel budgets are to be agreed at time of booking.
- Fitting fees are to be agreed at time of booking.
- If hire is in a remote location inaccessible by public transport, transport must be provided by the client.

PAYMENT TERMS

Cancellations

- The Model Hub must be notified in writing of cancellations at least 24 hours prior to the hire start time
- Bookings cancelled with more than 24 hours notice will incur no fees.
- Bookings cancelled within the 24 hour notice period will result in half the hire rate plus agency booking fee being charged.
- The Model Hub must be notified at time of booking if a location shoot may be weather dependant – if agreed in advance with the agency and model, no cancellation fee will apply.

Invoicing

- All invoices will be sent via email and standard payment terms are 30 days from date of invoice.
- Invoices are sent to primary booker, however if a booking is made on behalf of another client (such as a designer, stylist, etc), please state this at time of booking. Payment responsibility defaults to primary booker if client fails to make payment for any reason.
- Payment may be made by BACS Transfer, PayPal, Cheque or Cash – no credit or debit card facility available
- PayPal will incur an additional 5% transaction fee.
- Digital receipt will be emailed within 24 hours of payment.
- Payment is for the model and agency time and once shoot/event takes place, even if images are not used, payment must still be made.
- Any images taken may not be used until payment is made in full.

GENERAL TERMS

Model Use & Safety

- Models have indicated upon acceptance into our agency the type of work they are willing to do, which is reflected on their portfolio z-cards supplied to all clients. Any hire which may deviate from these comfort zones must be first agreed with The Model Hub and model prior to the booking.
- For models aged under 18, we respectfully insist on clients allowing a chaperone to attend a booking, unless in exceptional pre-agreed circumstances.

Image Use

- Images of our models may be used for an unlimited period of time and worldwide as long as in the context of original permitted use.

Food / Drink

- Models will provide their own food/drink on shoots unless otherwise agreed with the client.

Insurance

- Clients have ultimate responsibility for the models safety throughout any booking and are to maintain appropriate insurance cover to underwrite its obligation to the models.
- The Model Hub is not responsible if the model fails to attend a booking and insurance cover should be in place to cover any losses suffered if the model does not keep a booking because of ill health or any other reason.

Feedback

- Models act as suppliers to The Model Hub and are not contracted or employed directly, instead working on a freelance self employed basis – however all models work to the strict terms of our Model Agreement which covers aspects such as expectations, professionalism and timekeeping. The Model Hub would appreciate any feedback, both positive and negative, following a hire on client experience.
